EU REACH – Cabot Corporation's Only Representative Information
CARBON BLACK PRODUCTS ONLY

Dear Valued Customer:

The purpose of this letter is to communicate your obligations if your company chooses to use Cabot Corporation's Only Representative under the EU Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) Regulation.

As Cabot Corporation (Cabot) has informed you in the enclosed notification letter of July 1st, 2016 Cabot Performance Materials Belgium SPRL (CPMB) of Rue Prévôchamps, 78, B-4860 Pepinster, Belgium has been appointed Cabot's Only Representative (OR) under the European Union's (EU) Registration, Evaluation, Authorization and Restriction of Chemicals (REACH), Regulation (EC) No 1907/2006 of the European Parliament and of the Council of 18 December 2006,

We, Cabot Performance Materials Belgium SPRL (CPMB), have completed registration activities for Carbon Black, marketed as BLACK PEARLS®, ELFTEx®, MACHEM®, MOGUL®, MONARCH®, REGAL®, SHOBLACK®, SPHERON®, STERLING®, VULCAN®, CSX™, CRX™, IRX™, and UNITED® Grades.

CPMB, as the OR, has an ongoing obligation to monitor the volume and use of those substances for which it serves as OR entering the EU, per importer. This allows the importer to be regarded as the Downstream User (DU) of CPMB and thus free of any obligation to register the substance under REACH. Only importers from whom CPMB has obtained such information can be considered CPMB's DU. **If an EU importer does not make CPMB aware of the uses and volume imported into the EU, the EU importer may still have a registration obligation.**

CPMB would like to remind Cabot DUs that it is your responsibility to provide details regarding your EU importers (including name and address of the company, a contact name, e-mail address, and telephone/fax number), the uses and the yearly quantities exported to each importer in the EU. Such details should be reported to CPMB via the enclosed spreadsheet. The DU must provide the above information to enable CPMB to evaluate and monitor adequately the ongoing uses and volumes of substance in the EU, as required.

If your company chooses to use Cabot Corporation's Only Representative under REACH, please return the requested information to CPMB via the email address noted on the enclosed spreadsheet.
